

#### **ADVISORY INFORMATION**

IMPORTANT: When applying this product under the terms of this Extension of Authorisation, comply with any resistance guidance or restrictions stated on the product label.

Total reliance on one pesticide will hasten the development of resistance. Pesticides of different chemical types or alternative control measures should be included in the planned programme. Alternating with different modes of action is a recognised anti-resistance strategy.

This Extension of Authorisation relates to the use of 'Fytosave' (M18433) on the outdoor crop of hops and the crops of strawberry, blackberry, raspberry, loganberry and rubus hybrid grown outdoors, under protection and under permanent protection with full enclosure for the control of powdery mildew.

This product should be applied via horizontal boom arm or hand held sprayers in the following water volumes:

Blackberry, raspberry, loganberry and rubus hybrid and strawberry: 400 to 1000 litres of water per hectare.

Hops: 500-1000 litres of water per hectare.

This Extension of Authorisation has been re-issued to amend the maximum individual dose of some uses. This notice replaces authorisation 20191788 which will be withdrawn immediately.

## APPENDIX 2: GENERAL CONDITIONS FOR AN EXTENSION OF AUTHORISATION
