These conditions are issued subject to the provisions of the Environmental Management Act No. 12 of 2011, the provisions of Part V of the Environmental Management (Licensing) Regulations, Statutory Instrument No. 112 of 2013 and the following specific conditions:

These conditions shall be valid for the *Importation of:* Fytosave (Oligosaccharide Complex) a product of **Bancella Limited, Mauritius** only.

- a) Fytosave shall be valid for the following use only: As a Bio fungicide
- b) Bancella Zambia Limited shall ensure that the Fytosave imported into Zambia bears a label which is approved by the Zambia Environmental Management Agency (ZEMA).
- c) Bancella Zambia Limited shall ensure that the *labelling* requirements of the Fytosave shall be as set out in the Eleventh Schedule of the Environmental Management (Licensing) Regulations, Statutory Instrument No. 112 of 2013.
- d) The Fytosave shall be packed in a container or package that-
 - does not react chemically or physically with Fytosave; and
 - II. is capable of preventing the handling and transportation.
 - e) Bancella Zambia Limited shall notify ZEMA at least ninety (90) days before the arrival of the Fytosave as set out in Form XIII of the First Schedule of the Environmental Management (Licensing) Regulations, Statutory Instrument No. 112 of 2013.

ENVIRONMENTAL MANAGEMENT ACT NO 12 OF 2011 AND THE ENVIRONMENTAL MANAGEMENT (LICENSING) REGULATIONS, 2013

Bancella Zambia Limited shall use a transporter with a valid Pesticides and Toxic Substances Licence for transportation of **Fytosave.**

- g) Bancella Zambia Limited shall send bi-annual reports related to the Importation of Pesticides and Toxic Substances to ZEMA without fail on or before July 15 and January 15 for each year of the validity period for the licence in the attached format. In addition, electronic copies of the Reports shall be sent to- returns@zema.org.zm.
- h) The licence is valid for a period of three years from the 26th day of August 2021 to 25th day of August, 2024 and may be renewed for a like period if Snow Trade Limited complies with these conditions.
- i) Bancella Zambia Limited shall not transfer the licence to a third party without the prior approval by ZEMA.
- j) An application for **renewal and/or transfer** shall be made at least six months before the expiry of the licence.
- k) ZEMA may **revoke and/or suspend** this licence at any time and **without notice** in the event that Bancella Zambia Limited fails to comply with these conditions.
